- 1. Any individuals who operate a truck, car, tractor or any other type of vehicle in the parade must possess a valid driver's license for the class of vehicle being operated. In addition, all trucks, cars, tractors or other types of vehicles being operated in the parade must contain current registration, inspection and insurance pursuant to the laws of the Commonwealth of Pennsylvania, and proof thereof shall be provided if requested by the Norristown Parade Committee."
- 2. The Norristown Parade Committee reserves the right to limit the number/type of vehicles and other entries in the parade.
- 3. Deadline for entries is June 10, 2011.
- 4. Entries received after the June 10, 2011 deadline will be accepted only upon approval from the Parade Committee Chair.
- 5. All participants are expected to abide by general behavior guidelines. Note: the throwing of candy and other objects is strictly prohibited.
- 6. The Norristown Parade Committee does not endorse the views, representations, and behaviors of parade participants.
- 7. All floats, instrumental marching and non-instrumental marching groups will be considered for judging.

The organization named on this application irrevocably grants the Municipality of Norristown and the Norristown Parade Committee the exclusive right to use in any media our name, likeness, photos or reproduction or our performance for any purpose including promotion, advertising or otherwise. Furthermore, I/we hereby understand and agree to accept the risk of bodily injury and/or property damage which I/we may incur or cause a third party to incur as a result of my/our participation in the Norristown 4th of July Parade.
